## Introduction

EDGEBITS Limited is committed to achieving Net Zero emissions by **2032**.

## Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.


## Baseline Year: 2022

Our carbon reduction exercise was undertaken in December 2022. The aim of the exercise was to understand our carbon footprint and help us develop a strategy to lower our emissions.

Our target date for net zero emission is 2032. This is ahead of the Paris Agreement, which states emissions need to be reduced by 45% by 2030 and reach net zero by 2050.

Our activities and commitments to reaching Net Zero include:

- Signing up to the SME Climate Hub with a public commitment to reduce our emissions to Net zero by 2032.
- Where possible, using Microsoft teams to reduce the use of company cars and travel. Where not possible, assess whether public transport is a feasible option.
- Switching to electric/plug-in hybrid vehicles.
- Removing use of all Diesel vehicles
- Installation of electric vehicle charging points at the company office to increase viability for staff to have electric vehicles.
- Implementation of a company policy stating that all company cars should have an emissions rating lower than 100 gCO<sub>2</sub>/km.
- Rolling out a 'cycle to work scheme' where feasible. Communicating our environmental policy and performance on a regular basis, and encourage feedback.
- Communicating the importance of environmental issues to our team.
- Working together with our team, service partners, suppliers to promote improved environmental performance.
- Promote appropriate consideration of sustainability and environmental issues in the services we provide to our customers.
- Set and monitor key objectives and targets for managing our environmental performance.
- Review our environmental policy regularly.
- Reduce, reuse and recycle our waste and manage our waste to prevent pollution.
- Taking into account environmental impact when assessing the procurement of goods and services.
- Complying as a minimum with all relevant environmental legislation.
